## **Dr. Raymond G. Romanczyk**



Dr. Romanczyk is a SUNY Distinguished Service Professor and faculty member of the Clinical Psychology graduate program at SUNY Binghamton. He is a licensed clinical psychologist and a Board Certified Behavior Analyst specializing in the problems of children. He received his undergraduate degree from SUNY at Stony Brook and his M.A. and Ph.D. from Rutgers University. Dr. Romanczyk is the founder and director of the Institute for Child Development. Dr. Romanczyk has been involved in advocacy, program development, the judicial and legislative process as expert witness, and direct services to children and families for over 35 years. He is also former Director of Clinical Training and served two terms as Chairperson of the Department of Psychology at SUNY Binghamton. In addition, Dr. Romanczyk is an Adjunct Professor of Psychiatry of the SUNY Health Sciences Center of Syracuse.

Dr. Romanczyk is a Fellow of the American Psychological Association and his extensive professional activities include member and officer in numerous professional organizations, serving on the board of directors and board of advisors of several nationally recognized institutes and treatment facilities, consulting for numerous education and treatment programs and state government, serving as a grant reviewer for federal agencies, and on ethics and quality assurance boards for several organizations. He is a founding board member of the Association of Professional Behavior Analysts and currently a member of the scientific advisory board of the National Autism Center and a former board member of the Behavior Analyst Certification Board. He is a consultant to the NYS Department of Health (NYSDOH) Early Intervention Program and was on the NYSDOH Clinical Practice Guideline Development Panel for autism/pervasive developmental disorders, one of the first empirically based reviews of autism assessment and treatment practices. He also serves as a member of the editorial board and reviewer for numerous professional journals. Recent published works include, "Continuum-Based Model of Behavioral Treatment for Children with Autism: A Multi-factor and Multi-dimensional Perspective", "Autism & the Physiology of Stress and Anxiety", and "Social Skills vs. Skilled Social Behavior: A Problematic Distinction in Autism Spectrum Disorders." Dr. Romanczyk has presented several hundred addresses at regional, national, and international professional conferences regarding his applied and research work at the Institute, and has received numerous awards for his clinical and research accomplishments. He recently co-authored the book, "Defying Autism", written for parents and professionals.

### ***Abstract***

#### **ASD and Anxiety: Expression in Phobias, Behavior Problems, and Social Development**

Raymond G. Romanczyk, Ph.D., BCBA-D  
Institute for Child Development, SUNY at Binghamton

Description: This presentation will address recent intervention research and clinical practice for individuals with ASD who display anxiety and anxiety-related clinical problems. Anxiety is a hypothetical construct that describes a complex cluster of behaviors and physiological state that vary in proportion to one another from individual to individual. Unfortunately the term anxiety is often used very imprecisely and in that form adds little to an analysis of behavior. The process of anxiety development and maintenance will be discussed as well as clinical examples. The benefits as well as detriments to attempting to influence anxiety will be presented within the context of social and adaptive skill development. Cautions concerning well intentioned but poorly conceived therapy will be highlighted.

#### Objectives:

1. Review prevalence of anxiety and anxiety related disorders in ASD.
2. Describe necessary assessment and clinical conceptualization steps.
3. Present model examples of effective intervention.

## Dr. Joanne Gerenser



Dr. Gerenser is the Executive Director of the Eden II Programs. She received her Master's degree in Speech and Hearing at the Ohio State University and her Ph.D. in Speech and Hearing Science at the City University of New York Graduate Center. She is an adjunct Assistant Professor at Brooklyn College as well as Penn State University. Dr. Gerenser is a member of the Scientific Advisory Council for the Organization for Autism Research. She is co-author of the interactive CD-ROM entitled "Behavioral Programming for Children with Autism". She has authored several book chapters and articles on autism and developmental disabilities. Dr. Gerenser is an Associate Editor of the Journal of Speech-Language Pathology and Applied Behavior Analysis. She sits on a number of Professional Advisory Boards for several programs serving children and adults with autism in the US and abroad. She has received numerous awards for her work with children and adults with autism, including the Nassau Suffolk Autism Lifetime Achievement Award, the Mosaic Foundation's Educator of Excellence Award, the Elija Chariot Award, the Lou Miller Business Leadership Award as well as Staten Island's Albert V. Maniscalco Community Service Award.

### **Abstract**

#### **The Key to a Quality of Life: Effective Communication**

*Joanne Gerenser, Ph.D., CCC-SLP*

Communication has been broadly defined as the process of meaningful interaction among human beings. Deficits in communication skills are consistent with ASD, across all levels of functioning. In fact, it can be argued that autism is a severe disorder of communication. This presentation will review the core issues in ASD that impact the development of effective communication skills as well as the impact that limited communication skills have on all other aspects of functioning. The focus will be specifically on these issues as they affect adolescents and adults with ASD. Implications for intervention, program development and policy will be discussed.

Objectives:

Following this presentation, participants will be able to:

1. Identify the core issues in ASD that impact on the development of effective communication skills
2. Discuss the impact of limited communication skills on other aspects of functioning, particularly employment, social interaction, and community access.
3. Discuss the role of effective communication skills on quality of life.
4. Describe different strategies to promote effective communication skills in adolescents and adults with ASD
